### **Declaration of liability**

With this I declare and acknowledge by my signature that I enter the grounds of the RHR company exclusively and unlimited at my own risk, that I stay there and that I use their carts. The RHR company is not liable for damages resulting from the running of a rented cart and/or for those damages caused by the running of other vehicles, their drivers and/or my behaviour. Setting foot on and staying on the compound of RHR company, as well as participating in all activities occurs exclusively at my own risk. Liability for every possible damage is out of the question. Restricted liability is not applied if damages occur caused by the RHR company or by an employee because of carelessness or intention.

I accept the responsibility under civil and criminal law for the damages to persons, material or fortunes caused by myself or by the cart driven by myself. If the RHR company is made liable for compensation of damages that I caused, I grant the RHR company their first demand.

I assure you that I don't suffer from any physical disability or alcohol/drug addiction that influences my driving abilities. I will obey all the orders of the RHR company and /or their employees without exception. I accept unlimited liability for all the damaged that were caused on the cart that I hired because of improper treatment or because of my refusing to obey orders by the RHR company or their employees. Offences will be prosecuted if necessary. Legal domicile is Korneuburg.

I agree that my dates mentioned above will be stored for data processing sake and will be used exclusively by RHR company.
